The Investment Connection Platform is a website, which allows organizations to create, edit, and submit proposals for consideration.

A link to the online platform will be available on our website on September 30. Organizations will be asked to create a username and password for access to the site. Once you have created a profile, you may create your proposal. The site will also allow you to save an edit your proposal. More detailed instructions on how to use the website will be available on August 30.

Step 1: Create a Username and Password

You will need a valid email address to create an online profile to use investment connection. Your profile will allow you to create, edit, and submit your proposal.
